## EMPLOYMENT OPPORTUNITY

### PER DIEM FIREFIGHTER / EMT

Wilmington Fire Department Inc. No.1 is currently looking to hire per diem Firefighter / EMTs.

#### **Position Summary:**

This position requires employees to work in high stress, loud, and potentially dangerous situations. The employee must be capable of handling the physical demands of the essential functions of this position and must be able to work well within a combination volunteer/career department. Additionally, employees must provide accurate, timely, and high-quality service to all internal and external customers within a municipal environment. The employee must be highly motivated and be able to work independently and occasionally without direct supervision.

Position requires employee to work 12-hour shifts and is not part of a collective bargaining agreement.

**The starting pay for this position is \$19.00 per hour for firefighter/EMT shifts.**

**Minimum Requirements at time of application (proof must be submitted at time of submission/application):**

1. Minimum two years' experience as Firefighter / EMT.
2. High School Diploma or GED.
3. Certified State of Connecticut Emergency Medical Technician (EMT).
4. Current CPR certification.
5. State of Connecticut, IFSTA, or Pro-Board certification as a Fire Fighter I.
6. Hazardous Materials Operational-level certification.
7. Valid State of Connecticut Class D Driver's License with Q Endorsement or CDL.

**Willington Fire Department Inc No.1 would also prefer (but not require) applicants to have some of the following qualifications/certifications:**

1. State of Connecticut, IFSAC, or Pro-Board certification as a Fire Fighter II.
2. State of Connecticut, IFSAC, or Pro-Board certification as a Pump Operator.
3. Experience operating as a primary ambulance attendant on a 911-ambulance service.

**To Apply:**

Applicants must submit the following (ALL documents must be submitted/received for the application to be considered complete):

2. Letter of Interest.
3. Résumé of qualifications relevant to the position.
4. Three personal references.
5. Other documentation / information the applicant wishes to have taken into consideration for the position.

**Any offers of employment will be subject to the following (conditional offer of employment):**

1. Verification from a physician permitting the applicant to perform firefighter functions.
2. Pre-Employment drug screen.
3. Background check
